Note:- 1) The above vacancy is now in existence. The Ranked List published as per this notification will be valid until candidates are advised and appointed against the vacancies earmarked for the above community but kept unfilled due to the paucity of candidates belonging to Ezhava/Thiyya/Billava community during the currency of the mother Ranked List published on 05.10.2018 (as per Category No. 278/2014) for the post. This is the IV NCA Notification published due to the non availability of candidates as per the notification in the Gazette dated 13.06.2014(Category No.278/2014), First NCA Notification in the Gazette dated 15.10.2019 (Category No.170/2019), Second NCA Notification in the Gazette dated 15.12.2020 (Category No.346/2020) and Third NCA Notification in the Gazette dated 15.06.2022 (Category No.206/2022).

- 2) The Kerala Public Service Commission shall have the power to cancel the advice for appointment of any candidate to the above post, if it is subsequently found that such advice was made under some mistake. On such cancellation the appointing authority shall terminate the service of the candidate, provided that, the cancellation of advice for appointment by the Commission and subsequent termination of service of the candidate by the appointing authority shall be made within the period of probation or 240 days from the date of joining duty whichever is earlier.

: 18-42, (only candidates born between 02.01.1981 and 01.01.2005 are eligible to apply for this post) (both dates included). (including the relaxation as per para 2(i) of the General Conditions).

Note:- The provisional hands working in the above concern will be given age relaxation to the extent of their provisional service put in subject to a maximum of Five years from the upper age limit provided they are within the prescribed age limit on the date of their first appointment in the above concern. But the regular employees of the concern are not eligible for the above concession for further appointment. The provisional hands should obtain a certificate showing the period of their provisional service in the concern and shall produce the same as and when required by the Commission. It would also be clearly specified in the certificate that they were not working in the regular service of the concern.

The photograph once uploaded meeting all requirements shall be valid for 10 years from the date of uploading. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile candidate must ensure correctness of the information in their profile. They must quote the User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. Candidates are advised to keep a printout or soft copy of the online application for future reference. Candidates can take the printout of application by clicking on the link 'My applications' in their profile. All correspondences with the Commission, regarding the application should be accompanied with the print out of the application. The application will be summarily rejected if noncompliance with the notification is found in due course of processing.
