- (i) The above vacancies are now in existence. The Ranked list published as per this notification will be valid until candidates are advised and appointed against the vacancies earmarked to the above mentioned Communities but remains unfilled due to paucity of candidates during the currency of the Ranked List published on 09.04.2021 for the above post notified under Category No. 387/2018. This is the Second NCA notification issued due to non-availability of qualified candidates belonging to the above communities in response to the First NCA notification (Gazette dated: 15/12/2021, Category No. 627/2021 631/2021).
- (ii) The selection in pursuance of this notification will be made on statewide basis.
- (iii) As per Rule 184 of KCS every person appointed to this post shall from the date on which he/she joins duty be on probation for a period of One year on duty within a continuous period of two years.
- (iv) Candidates who are appointed as Sales Assistant Grade II by Direct Recruitment through Public Service Commission will have to work in showrooms outside Kerala.
- **5. Method of appointment**: Direct Recruitment from among the eligible employees belonging to Ezhava/Billava/Thiyya, Scheduled Caste, Muslim, Latin Catholic/Anglo Indian, OBC Communities of the Member Societies affiliated to Kerala State Co-operative Coir Marketing Federation Limited.

Note:-

(i) Application submitted by candidates who are not regular employees of member societies affiliated to Kerala State Co-operative Coir Marketing Federation Limited. and who belong to communities other than Ezhava/Billava/Thiyya, Scheduled Caste/ Scheduled Tribe, Muslim, Latin Catholic/Anglo Indian, OBC will be rejected. Individual communication regarding the rejection will not be issued to such candidates.

- (ii) In the absence of candidates belonging to scheduled caste community, candidates belonging to scheduled Tribe community will also be considered.
- 6. Age : 18 50 years. Candidates born between 02.01.1973 and 01.01.2005 (Both dates included) are only eligible to apply for this post.

7. Qualifications:

- 1) Must have 3 years regular service in any cadre in the Member Societies affiliated to the Kerala State Co-operative Coir Marketing Federation Limited. Candidates selected under this Category should be in service of the Member Society not only on the date of application but also on the date of appointment to the new post.
- 2) Degree in any discipline from a recognized University.
- 3) Should have studied Hindi atleast upto +2 level
- 4) Typewriting English (Lower) KGTE

Successful completion of a course not less than six months duration in Computer Application recognized by State or Central Government.

- (2) The requirement that the employees should be in service of the society on the date of appointment to the Post in pursuance of this notification will not be applicable to those who were recruited through the PSC to a post in the Apex/Central Societies reserved for the employees of the affiliated Primary Co-operative/Member Societies, provided they are continuing in service in that post.
- (3) In addition to the qualifications prescribed in this notification, the qualifications recognized by Executive Orders or by Standing Orders of Government as equivalent to a qualification specified for a post in the Special Rules and such of those qualifications which pre-suppose the acquisition of the lower qualification prescribed for the post shall also be sufficient for the post. The copy of the Government orders declaring equivalent / higher qualifications shall be produced as and when required by the Commission.

9. Mode of submitting applications:-

- (a) Candidates must register as per ONE TIME REGISTRATION with the official Website of Kerala Public Service Commission www.keralapsc.gov.in before applying for the post. Candidates who have registered can apply by login on to their profile using their User-ID and Password. Candidates must click on the 'Apply Now' button of the respective posts in the Notification Link to apply for a post. The Photograph uploaded should be one taken after 31.12.2012. Candidate who register first time should upload photo taken within 6 month from the date of their registration. Name of the candidate and the date of photograph taken should be printed legibly at the bottom portion of the photograph. The photograph once uploaded meeting all requirements shall be valid for 10 years from the date of uploading. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile candidates must ensure correctness of the information in their profile. They must quote the User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. Candidates are advised to keep a printout or soft copy of the online application for future reference. Candidates can take the printout of the application by clicking on the link 'My applications' in their profile. All correspondences with the Commission, regarding the application should be accompanied with the print out of the application. The application will be summarily rejected if non-compliance with the notification is found in due course of processing. Original documents to prove qualification, experience, age, Community etc. have to be produced as and when called for.
- (b) If written/OMR/Online Test is conducted as part of this selection, candidates shall submit a confirmation for writing the examination through their One Time Registration Profile. Such candidates alone can generate and download the Admission Tickets in the last 15 days till the date of Test. The applications of candidates who do not submit confirmation within the stipulated period, will be rejected absolutely. The periods regarding the submission of confirmation and the availability of Admission Tickets will be published in the Examination Calender itself. Information in this regard will be given to the candidates in their respective profiles and in the mobile phone number registered in it.

13. Special Instructions to Candidates

- 2) Candidates are required to acquaint themselves with the instructions given in the notifications as Part II, General conditions before submitting application for the post. Applications which are not submitted in accordance with the terms and conditions laid down in the General Conditions are laible to be rejected.
