- (iii) The selection in pursuance of this notification will be made on a Revenue District basis, subject to the special conditions laid down in GO (MS) No.154/71/PD dated 27/05/1971. A candidate advised for appointment in one revenue District from the Ranked List prepared is not eligible for transfer to another District unless he/she completes five years continuous service from the date of commencement of service in the former District. Even if transfer is allowed after five years, it will be subject to the rules in G.O. (MS) No.4/61/PD dated 02.01.1961. Candidates already in Government service holding the same post in any one District are prohibited from applying again for this post, but they can apply to

ii) A pass Certificate obtained after successful completion of Nurse-Cum-Pharmacist Training Course (Homoeopathy) conducted by the Government of Kerala / A pass in Certificate Course in Pharmacy (Homoeopathy) conducted by the Government of Kerala or its equivalent qualification recognised by the Government.

Note :-

(i)Rule 10 (a) (ii) of KS&SSR Part II is applicable.

(ii) In addition to the qualifications prescribed in the notification, the qualifications recognized by executive orders or standing orders of Government as equivalent to a qualification specified for a post, in the Special Rules or found acceptable by the Commission in cases where acceptance of equivalent qualifications is provided for in the rules and such of those qualifications which presuppose the acquisition of the lower qualification prescribed for the post, shall also be sufficient for the post. The copy of the Government orders declaring equivalent/higher qualifications shall be produced as and when required by the Commission.

Candidates must click on the **'Apply Now'** button of the respective posts in the Notification Link to apply for a post. The Photograph uploaded should be taken after 31.12.2013. Name of the candidate

and the date of photograph taken should be printed legibly at the bottom portion. The photograph once uploaded meeting all requirements shall be valid for 10 years from the date on which the photograph was taken. Those candidates who are creating new profile should upload photograph taken within the last six months from the date of their registration. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile candidates must ensure correctness of the information in their profile. They must quote the User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. Candidates are advised to keep a printout or soft copy of the online application for future reference. Candidates can take the printout of the application by clicking on the link 'My applications' in their profile. All correspondences with the Commission, regarding the application should be accompanied with the print out of the application. The application will be summarily rejected if non-compliance with the notification is found in due course of processing. Original documents to prove qualification, experience, age, Community etc. have to be produced as and when called for. Candidates who have AADHAAR card should add AADHAAR card as I.D. Proof in their

profile.

ii)Candidates are required to acquaint themselves with the instructions given in the notification as Part II, General Conditions before submitting application for the post. Applications which are not submitted in accordance with the terms and conditions laid down in the General Conditions are liable to be rejected.

iii)Appropriate disciplinary action as per Rule 22 of the Kerala Public Service Commission Rules of Procedure, 1976 shall be initiated against those candidates whose submit applications with bogus
